Waiver and Release

While Portland-Kaohsiung Sister City Association (PKSCA) is taking safety seriously, we cannot guarantee to protect participants from contracting a coronavirus, its variants or injury while practicing in a PKSCA dragon boat. Dragon boat paddling cannot be conducted using all CDC guidelines. Therefore:

I agree:

- 1. I am fully and personally responsible for my safety and actions during my participation in PKSCA activities and I recognize that I may be at risk of contracting a coronavirus or its variants or injury. I am willing to accept the risk. By signing below, I agree to accept all responsibility for the risk that I may contract a coronavirus, its variants, or injury.
- 2. With full knowledge of risks involved, I hereby release, waive, and discharge PKSCA, its board of directors, officers, agents, volunteers, participants, employees, independent contractors, representatives, affiliates, successors and assigns, and all other persons or entities acting on any capacity on their behalf from all liabilities, claims, demands, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury or death that may be related to contracting a coronavirus, its variants, or injury out of participation in activities of PKSCA.
- 3. To indemnify, defend, and hold harmless PKSCA from and against all costs, expenses, damages, lawsuits, and/or claims made against any of the released parties due to loss, or death related to a coronavirus, its variants, or injury.
- 4. If I take any steps to make a claim for damages against PKSCA, board of directors, officers, agents, volunteers, participants, employees, independent contractors, representatives, affiliates, successors and assigns, and all other persons or entities acting on any capacity on their behalf arising out of participation in activities of PKSCA, I shall be obligated to pay all legal fees and costs incurred by such parties as result of such claim.
- 5. In the event I have been exposed to or diagnosed with a coronavirus or its variant, I will immediately notify the team captain or PKSCA official.
- 6. If I am unable to be fully vaccinated for any reason, I will consult with my Team Captain who will then consult with the appropriate PKSCA official.

By signing below, I acknowledge that I have read the foregoing Release of Liability and Agreement Not to Sue, Indemnify, Hold Harmless and understand its content. I am at least eighteen (18) years old and full competent to give my consent or I am younger than eighteen (18) and my legal guardian has signed consent in my stead below.
